Recovery Is Well On The Way

Though the global recession continues to create challenges for Canadian families and businesses, we are increasingly seeing signs that we are edging closer to recovery. However, the recession is not over yet, so our Conservative government is taking action to help strengthen our economy.

Recently, we've seen some positive news about our economy. For instance, the Canada Mortgage and Housing Corporation reported that home construction went up by 12% in August. As part of Canada's Economic Action Plan, our Conservative government is helping Canadians to purchase their homes with tax incentives and opportunities. One example is the First Time Home Buyers' Tax Credit, which provides up to \$750 in tax relief that can be put towards closing costs, legal fees and disbursements. We also introduced the popular Home Renovation Tax Credit program, which provided incentive for Canadians to make improvements to their properties while at the same time stimulating sales in building supply stores and creating jobs for the trades.

We are also starting to see more jobs created across Canada. In August, 27,000 new jobs were created. At the same time, the unemployment rate increased by 0.1% as more people began looking for new jobs. However, this was also a difficult summer for students seeking employment, as the global recession had many companies trimming summer positions. Our response was

to increase the budget for the Canada Summer Jobs program by \$20 million. This program helps fund student employment in the not-for-profit sector, giving students both valuable experience and needed income, while helping not-for-profits manage labour costs. Our stimulus package has invested in the following projects in Delta – Richmond East:
